How to get started

To sign up on a traineeship you need to seek your employer’s approval before proceeding. Then contact CTAS Education for an expression of interest form which needs to be signed by you and your employer. Once this form has been returned, CTAS Education will then contact an Apprenticeship Network Provider, who will visit you in your workplace to sign you up on a traineeship with Apprenticeship Office. If you have previous qualifications in the same industry, this may be used in the RPL (Recognition of Prior Learning) process and you should present your statement of attainment to CTAS Education during your enrolment visit.

Definitions

New Worker Trainees: A new worker trainee is defined as a person employed with the same employer continuously for less than three months full time or 12 months part time immediately prior to commencing a traineeship.

Existing Worker Trainee: An existing worker trainee is defined as a person employed with the same employer continuously for more than three months full time or 12 months part time immediately prior to commencing a traineeship.

Secondary School Aged Student: A secondary school aged student is a person who has reached 15 years of age but has not reached the end of the calendar year in which their compulsory education period expires. In 2022, these persons will be born on or after 1 July 2004.

School Based Trainee: A school based trainee is a person who is enrolled at school, as defined in the School Education Act 1999 and undertaking a traineeship.

Fees for Service Student: A fees for service student is a person who is enrolled in a training program that is not publicly funded. For example a person who is ineligible for a traineeship.

PIT Student A PIT Student is a person who is enrolled in a training program that is publicly funded by Priority Industry Training (PIT). For example, a person who is ineligible for a traineeship.
